# The Facts That Drive My Decision to not receive the Covid-19 Vaccine

This is a list of facts that are borne out of the many reports linked from this website. I'm not including reference links on this document. If you are interested learning more on each of these facts, dig through the documents on the "Critical Information" page, or read through the reports on the Daily Reading pages. Please understand, these facts come board certified, and many nationally recognized, Medical Doctors; as well as scientists, educators, experts, published and peer reviewed medical reports, and other respected investigators and reporters.

### COVID BASIC FACTS:

- 1. Let's start with the obvious fact that Covid-19 can be a very dangerous disease.
- 2. It is especially dangerous for the elderly, and those with comorbidities (diabetes, heart disease, obesity, etc.).
- 3. A very large percentage of deaths (US average 12/20=38%) were in nursing homes. Early in the pandemic some states forced nursing homes to admit covid infected patients, thereby increasing infections and deaths in this vulnerable population. Investigations into this practice are currently ongoing.
- 4. Hospitalization rates in the US for Covid-19 are approx. 2% of those that become infected. For those over 65 the rate is within ranges of Influenza rates, somewhat higher for 18-64 and much lower for <18.
- 5. The global fatality rate (deaths as a % of the total global population) of Covid is 0.035%. This compares to rate of 2.8% for the 1918 Spanish Flu pandemic, and approx. 30-60% for the Black Plague in the 1300's.
- 6. The standard method of treatment in the US from doctors, is to keep infected patients' home, with minimal treatment (i.e., Tylenol), and to go to the ER if they take a turn for the worst. Why don't we treat them early?
- 7. Many medical professionals in hospitals have reported treatment protocols that have been detrimental to the health of patients. (i.e., respirators, remdesivir, lack of treatment for pneumonia, etc.).
- 8. There is no asymptomatic spread. You must have symptoms to spread.
- 9. Children are at extremely low risk of serious infection and even lower risk of death (ages 5-14: 1/1,000,000; for comparison traffic accidents are 15x greater and suicides are 10x greater). Also, they do not spread it at home or in schools.
- 10. Lockdowns are not effective at stopping the spread of the virus, and lead to other health complications.

# EARLY TREATMENT:

- 11. Protocols including Hydroxychloroquine, Ivermectin, etc., for prophylactic and early treatment have been proven effective by many doctors in the US and internationally.
- 12. These early treatment protocols, especially Hydroxychloroquine and Ivermectin have been maligned in the press, by the medical establishment and the governmental authorities.
- 13. Both medications have decades long safe use records by millions/billions of people (i.e., not "horse paste").
- 14. There is proof that these two medications slow the replication of the covid virus either by blocking the virus from being able to attach to your cells, and/or by helping Zinc to get into your inner cell machinery to block the virus from replicating.
- 15. Since no other form of early treatment has been available, why hasn't the medical establishment allowed for these safe treatment protocols?
- 16. Many US doctors report that their early treatments (within with these protocols on thousands of patients, have resulted in nearly 100% cure rates. Many studies prove similar results.
- 17. Many US doctors have used these protocols prophylactically to protect themselves, their staffs and many others from contracting Covid-19.

# PCR TESTS:

- 18. PCR tests detect fragments of viruses.
- 19. PCR tests can detect old infections that have been recovered from.
- 20. PCR tests were never meant to be an actual Covid-19 test.
- 21. PCR tests are not always able to distinguish between Covid-19, the common cold, or the flu.
- 22. PCR tests are run multiple times (cycles) to amplify any virus fragments in the original test sample to make them more detectable. As the cycles increase, the chance that it's detecting a false positive result increase.
- 23. If it takes 35 cycles before seeing a positive case result, then the level of viral fragments in the original sample were not of enough quantity to actually be infectious. US labs typically run 35-45 cycles.
- 24. Thus, infection cases in the US were exaggerated by the PCR tests.

#### MASKS:

- 25. Covid is primarily transmitted through the air, and to a lesser degree on surfaces.
- 26. The covid virus is approx. 0.1-0.3 microns in size (1/100<sup>th</sup> diameter of human hair). N95 masks filter 0.3 and greater.
- 27. Masks may stop droplet sized particles, but most of those are trapped by gravity and quickly fall to the ground.
- 28. The airborne particles we need to protect from are the extremely small aerosolized viral particles from a cough.
- 29. The normal cloth and paper surgical mask worn by most folks allow more than 90% of these viral particles through.
- 30. Properly fitted N95 masks allow approx. 5% of 0.3micron particles through.
- 31. Many studies prove that non-fitted, non-N95 masks are not effective at protecting from viruses the size of Covid-19.
- 32. Masks will collect multitudes of other pathogens, and when touching mask/face, causes these to spread.

#### VACCINE:

- 33. Let me start by stating: MEDICAL TREATMENTS SHOULD CAUSE NO HARM. This vaccine is causing harm.
- 34. These first of their kind mRNA vaccines were produced very fast (less than one year) and were not properly tested.
- 35. The normal vaccine approval process can take up to 10 years.
- 36. Normal vaccines consist of dead or disabled original virus. These new Covid-19 vaccines consist of mRNA (i.e., picture it as computer code that your body's cells can read), and this mRNA is surrounded by extremely small fat (lipid) shell. This lipid shell connects to any cells in your body and helps insert that mRNA code into your cell. This then causes your own cells to produce spike proteins by the billions.
- 37. These spike proteins that the vaccine makes your own cells produce, are the same spikes you see on the outside of the circular Covid-19 virus shell.
- 38. Your body recognizes these spike proteins as an invader and makes antibodies to destroy them. This is the premise of the new vaccines (all of them, including the Pfizer/Moderna mRNA vaccine, and the J&J adenovirus vaccine).
- 39. These spike proteins are only one protein contained in the Covid-19 virus. There are approx. 20 other proteins in the Covid-19 virus.
- 40. By focusing on only this one single protein, they have made it very easy for the vaccine to ultimately fail as the virus will mutate to get around that spike protein antibody in your immune system. We are seeing this happen with the Delta variant now. Natural immunity on the other hand (obtained after you survive a Covid-19 infection), gives you much more robust level of protection. Your body focuses on all aspects of the virus, all of the proteins that make up the virus, not just the one single protein of the "Spike".
- 41. These Spike Proteins are carried in your blood throughout your body. They are accumulating in organs, and they are causing blood clots (picture the spikes jamming up in capillaries and blocking blood cells from getting past).
- 42. There are 100's of thousands of serious adverse reactions and 10's of thousands of deaths being reported after taking these vaccines.
- 43. These adverse reactions and deaths are being ignored and even denied by the media, the government and medical establishment.
- 44. Those that report on the adverse reactions and deaths are being ridiculed, censored, and their careers destroyed.
- 45. Why can't there be a civil exchange of information on these adverse reactions for all to see, and to discuss
- 46. There has never been a successful coronavirus vaccine (i.e., common cold, SARS, MERS, etc.). ADE (Antibody Dependent Enhancement) is a major concern. This is where the antibodies produced by the vaccine, help future Covid variants enter into cells. We may be seeing this with the increasing number of cases of vaccinated getting serious illness.
- 47. The vaccine is NOT resulting in long term immunity. Immunity is only lasting a few months and is why booster shots are now being recommended.
- 48. All current vaccines produce the spike protein found on the original Alpha variant of Covid-19. They are not effective at stopping other variants such as delta which has a slightly different spike protein.
- 49. Unlike previous vaccines like Polio that protected you from catching Polio, the Covid vaccine does not protect from catching Covid-19. There have been many breakthrough cases and they are increasing. Recently there are more reports of significant hospitalizations and deaths of vaccinated individuals.
- 50. Vaccinated individuals can spread Covid to others. Vaccinated and unvaccinated carry the same viral load and can thus spread it equally.
- 51. There are reports that the vaccinated will not get the full protection of Natural Immunity obtained when you have survived a Covid-19 infection.
- 52. There are reports that the vaccine degrades the immune system, allowing other conditions such as Shingles, cancer, etc to manifest themselves.

#### **CENSORING:**

- 53. Doctor's that do not follow medical establishment protocols (i.e., do nothing in the early stages of the disease) are losing their jobs, their license to practice medicine, and losing past titles and even losing access to medical study websites.
- 54. These doctors are following legitimate alternative protocols that have been proven to work. Their only focus is to save their patients lives by offering therapeutic treatments for a disease where there are few official therapeutic treatment protocols.
- 55. Doctors, scientists and others that report on anything outside the "official narrative" are being censored and discredited.
- 56. Government medical entities are changing the definitions of terms to fit the "official narrative" (i.e., definition of vaccine, definition of a covid death, etc.)
- 57. Mainstream media, big tech and social media is hellbent on scaring their viewers, listeners, readers by exaggerating, lying and censoring.
- 58. They say they are doing this to protect, but they are doing a disservice by not allowing all sides of this story to be heard.
